That the permittee shall conduct annually stack emission testing for the One (1) One (1) unit 750kVA/600kW generator set (Categorized as MEDIUM size sources as per MC 2007-003) in compliance with RA 8749. Thereafter, the stack emission test report shall be submitted every June from CY 2019 to 2023;
- 2. That this Permit is subject to revocation if found violating Ambient and Source Emission Standards and other provisions of the Clean Air Act and its Implementing Rules and Regulations;
- 3. That any authorized DENR-EMB personnel with proper identification card and travel order shall be allowed unconditional access to conduct an on-the-spot inspection and monitoring to oversee its compliance to the permits and other applicable environmental laws without the need of prior notice to the proponent;
- 4. That non-compliance of any of the conditions set forth herein shall be sufficient cause for the suspension or cancellation of this permit and/or payment of fine in an amount not to exceed ten thousand pesos (P10,000.00) for every condition violated;
- 5. This operating Permit shall be posted in a conspicuous location near the equipment and shall be adequately framed or otherwise protected against damage.
- 6. That a Self Monitoring Report (SMR) on the operation and maintenance of the aforesaid installations shall be made quarterly and submitted based on the following schedule:



- APUI shall NOT be entitled to incentives under Republic Act No. 7916 (The Special Economic Zone Act of 1995), as amended;
- The entry and exit of goods and people into and from the premises of the Economic Zone shall be subject to the security procedures being implemented by PEZA;
- Any additional/new activity which APUI intends to undertake inside the Economic Zone shall require prior clearance from PEZA;
- APUI shall abide by all applicable PEZA rules and regulations in the Economic Zone as well as any subsequent issuances of PEZA which are related to and are applicable to APUI's operations in the Economic Zone;
- In case APUI decides to cease its operations inside the Economic Zone, APUI shall notify in writing the Zone Manager copy furnished the Ecozone Development Department; and

- 5. Ensure that the hazardous wastes disposed offsite are covered by a Permit to Transport; each transport is covered by a hazardous waste manifest duly signed by the transporter and TSD facility; and with corresponding Certificate of Treatment (COT) duly signed by the TSD facility. - 12. Monitor the importation or distribution of chemicals, especially those listed under the PCL and those with CCO and the generation of solid and hazardous wastes. Monitoring data shall be submitted as part of the SMR and the PCL Compliance Certificate (applicable only for importers or distributors of chemicals);
- Promptly submit CMRs and SMRs, duly accomplished and signed by the PCOs, approved and certified correct by the Managing Head, and notarized;
- 14. Report in writing within twenty-four (24) hours from the occurrence of any of the following environmental incident to the concerned EMB Regional Office, as the case may be:
  - Breakdown of any pollution source and/or control facility or monitoring instruments; or
  - Releases (e.g. leaks, spills, etc.) of chemicals or hazardous wastes (listed in Annex 1 of this Order as well as the Priority List of Hazardous Substances as published by the Agency for Toxic Substances and Disease Registry of the Department of Health & Human Services of the United States of America) to environmental media.

15. 



- That in case of transfer of ownership/management of this project, these same conditions and restrictions shall apply and the transferee shall be required to notify this Office within fifteen (15) days as regards to the transfer of ownership/management.
- That the proponent, APO Production Unit, Inc. (as represented by its EVP and General Manager, Mr. Jaime H. Aldaba) shall be severally accountable for any misrepresentation and failure to state material information in the submitted document.

The conditions stipulated in this Certificate shall be deemed final within fifteen (15) days from receipt hereof and all conditions and restrictions set forth above shall be complied with by the herein grantee. 9.4 Submit a quarterly environmental monitoring report using the prescribed format of the Self-Monitoring Report (SMR) pursuant to DAO 2003-27.

- 9.5 Submit an Abandonment Plan two (2) months prior to abandonment activities. It shall include rehabilitation measures/clean-up, costs, remediation of areas possibly contaminated with toxic/hazardous substances and presentation of options on proposed alternative projects in the area.
- That a Memorandum of Agreement (MOA) shall be entered into by and between the
  proponent with the Industrial Park to become part of the Multi-Partite Monitoring
  Team (MMT) and in setting up of the corresponding Environmental Monitoring
  Fund (EMF).
- 11. That when the implementation of the project causes adverse environmental impacts and/or pose nuisance to public health and safety, the proponent shall immediately suspend its project operation until such time that appropriate remedial measures are effected and/or any damage to persons and/or properties resulting from the same are properly compensated.
- 12. That health and sanitation practices shall be observed in all phases/stages of the project and safety & personal protective equipment/gadgets shall always be provided to the personnel within the premises of the project site to prevent health and occupational hazards.
- 13. That any authorized DENR-EMB personnel, with proper identification card and travel/mission order, shall be allowed unconditional access to conduct an on-the-spot inspection and monitoring to oversee compliance to the ECC without the need for prior notice to the proponent.


