Further, APUI is one of the three (3) recognized government printers that may handle the printing of accountable forms and sensitive high quality/volume printing jobs of Philippine Government agencies and offices, and recognized as such by Republic Act (RA) No. 11260 or the General Appropriations Act (GAA) of Fiscal Year 2019, Section 23 of General Provisions, and Government Procurement Policy Board (GPPB) Resolution No. 05-2010. Nevertheless, even if it is declared as a GOCC RGP, still it is not included in the National Budget. It has derived its funds, including expenses and employee's salaries, solely from its business operations and revenue it generates as a printer.

I hereby certify that as a GOCC Not Receiving any Budgetary Support from the Government, APUI is not covered under Circular Letter Nos. 2018-8 and 2018-12 both prescribing the Guidelines for the Conduct of Early Procurement Activities (EPA).
