**RECOMMENDING DECLARATION OF FAILURE OF BIDDING FOR THE  
PROCUREMENT OF ONE (1) LOT CBS1 CHECK PAPER 96 GSM WITH  
WATERMARKS THROUGH CONDUCT OF PUBLIC BIDDING UNDER SECTION  
10 OF THE REVISED IMPLEMENTING RULES AND REGULATIONS (IRR) OF  
REPUBLIC ACT (RA) NO. 9184**

**WHEREAS**, on 27 November 2017, Ms. Angelique S.A. Abadilla, Officer-in-Charge, as Head of the Procuring Entity, approved the Indicative Annual Procurement Plan ("APP") for CY 2018 upon favorable recommendation of the Bids and Awards Committee ("BAC");

**WHEREAS**, in accordance with the pertinent provisions of the revised IRR of RA No. 9184, the BAC posted the Invitation to Bid ("IB") for the Procurement of One (1) Lot CBS1 Check Paper 96 gsm with Watermarks (PB-03-18) an Approved Budget for the Contract ("ABC") amounting to One Million Three Hundred Thousand Pesos (**PhP 1,300,000.00**) in the website of Philippine Government Electronic Procurement System ("PhilGEPS"), APO's website and in conspicuous place in the premises of the APO;

**WHEREAS**, likewise in furtherance with the pertinent provisions of the revised IRR of RA 9184, representatives from the Commission on Audit ("COA") Resident Auditor, as well as observers from private sectors, were invited to observe and witness the conduct of the Pre-Bid Conference and the Submission and Opening of Bids as scheduled;

**WHEREAS**, on 20 December 2017, BAC convened for the scheduled Pre-Bid Conference. Despite the aforementioned postings, no bidders attended the Pre-bid Conference.

**WHEREAS**, on 21 December 2017, BAC, through Secretariat, issued Bid Bulletin No. 1 to clarify, modify and amend items in the Bidding Documents specifically in the Bid Data Sheet, Special Conditions of the Contract, Technical Specifications, and Schedule of Delivery.

**WHEREAS**, on the scheduled deadline for the Submission and Opening of Bids on 3 January 2018 at 3:00 P.M., BAC, through Secretariat, manifested that as of the scheduled deadline of submission of bids, no bidders submitted its bid;

**WHEREAS**, pursuant to Section 35.1 of the Revised IRR of RA 9184, the BAC shall declare the bidding a failure when:

- a.) No bids are received;

**WHEREAS**, in the interest of time and to protect the best business interest of the company, BAC resolved to recommend to the HOPE the declaration of failure of bidding and the proposed schedule for the conduct of a new bidding activity;

**NOW, THEREFORE**, We, the Members of the BAC, by the virtue of powers vested on us by law, after duly considering the recommendation of the Technical Working Group ("TWG"), hereby **RESOLVED** to recommend to the HOPE:

1. To declare a Failure of Bidding for the Supply And Delivery of One (1) Lot CBS1 Check Paper 96 gsm with Watermarks (PB-03-18) (PhilGEPS Reference No. 5045911) and;
2. To comply with the instruction stated under Section 53.2 of the revised IRR of RA 9184 in order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.


