**RECOMMENDING DECLARATION OF FAILURE OF BIDDING FOR THE
LEASE OF VARIOUS PRINTING MACHINES AND EQUIPMENT WITH
OPERATIONAL AND TECHNICAL SUPPORT SYSTEM THROUGH CONDUCT
OF PUBLIC BIDDING UNDER SECTION 10 OF THE REVISED
IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA)
NO. 9184**

WHEREAS, on 1 April 2019, Mr. Michael J. Dalumpines, Chairman and President, as Head of the Procuring Entity, approved the Annual Procurement Plan (“APP”) for CY 2019 upon favorable recommendation of the Bids and Awards Committee (“BAC”);

WHEREAS, in accordance with the pertinent provisions of the revised IRR of RA No. 9184, the BAC posted the Invitation to Bid (“IB”) for the Lease of Various Printing Machines and Equipment with Operational and Technical Support System (PB-09-19) with an Approved Budget for the Contract (“ABC”) amounting to One Million Nine Hundred Seventy Five Thousand Pesos (**PhP 1,975,000.00**) in the website of Philippine Government Electronic Procurement System (“PhilGEPS”), APO’s website and in conspicuous place in the premises of the APO last 12 March 2019;

WHEREAS, likewise in furtherance with the pertinent provisions of the revised IRR of RA 9184, representatives from the Commission on Audit (“COA”) Resident Auditor, as well as observers from private sectors, were invited to observe and witness the conduct of the Pre-Bid Conference and the Submission and Opening of Bids as scheduled;

WHEREAS, on 20 March 2019, BAC convened for the scheduled Pre-Bid Conference. Unfortunately, no bidder has attended the said proceeding;

WHEREAS, on the scheduled deadline for the Submission and Opening of Bids on 1 April 2019 at 1:30 P.M., BAC, through Secretariat, manifested that as of the scheduled deadline of submission of bids, no bidders submitted its bid;

WHEREAS, pursuant to Section 35.1 of the Revised IRR of RA 9184, the BAC shall declare the bidding a failure when:

- a.) No bids are received;

WHEREAS, in the interest of time and to protect the best business interest of the company, BAC resolved to recommend to the HOPE the declaration of failure of bidding and to conduct mandatory review and evaluate Bidding Documents for proposed re-bidding activity;

2. To conduct mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents for the same project pursuant to Section 35.5 of the Revised IRR of RA 9184.


