DECLARATION OF FAILURE OF BIDDING FOR THE DISPOSAL OF ASSORTED SCRAP PAPER TRIMMINGS

WHEREAS, on 6 January 2021, Mr. Michael J. Dalumpines, Chairman and President, approved to dispose approximately **63,427** Kilograms of scrap paper trimmings and paper core through public bidding on an "As-Is-Where-Is" basis as indicated below,

WHEREAS, representatives from the Commission on Audit ("<u>COA</u>") Resident Auditor, as observer was invited to observe and witness the conduct of the Submission and Opening of Bids and Bid Evaluation;

WHEREAS, Disposal Committee convened the scheduled Pre-Bid Conference on 15 January 2021. Subsequently, there were three (3) prospective bidders namely, (i) First Interscrap Trading Corp, (ii) Lexton Trading and (iii) JCZS Trading attended the said proceedings;

WHEREAS, on the scheduled deadline for the Submission and Opening of Bids on 19 January 2021 at 1:00 P.M. Four (4) Bidders namely, (i) First Interscrap Trading Corp., (ii) Riclen Junkshop, (iii) Izzie's Trading and (iv) Prince Chan Paper Company purchased the bidding documents but only Riclen Junkshop did not submit bid document. During the preliminary examination of bids, the Disposal Committee checked the submitted documents against the checklist or required documents to ascertain if they are all present and only First Interscrap Trading Corp. passed but subject for detailed evaluation and post qualification;

WHEREAS, during the post qualification on 21 January 2021 the Disposal Committee found and rated failed the 1st envelope containing the Technical Components of **First Interscrap Trading Corp.** for failure to affix the latest Mayors/Business Permit validity as required document in Competitive Bidding;

WHEREAS, the Disposal Committee declare the bidding a failure as All prospective bidders are declared ineligible;
