**RECOMMENDING DECLARATION OF FAILURE OF BIDDING THROUGH
CONDUCT OF PUBLIC BIDDING UNDER SECTION 10 OF THE REVISED
IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA)
NO. 9184**

WHEREAS, on 11 January 2022, Mr. Michael J. Dalumpines, Chairman and President, as Head of the Procuring Entity, approved the Annual Procurement Plan ("APP") for CY 2022 of APUI Production Unit, Inc. ("APUI") upon favorable recommendation of the Bids and Awards Committee ("BAC");

WHEREAS, included in the APP of APUI for CY 2022 is the **Supply and Delivery of One (1) Unit Brand New Van (PB-24-22)**. The Approved Budget for the Contract ("ABC") for the said project is One Million Four Hundred Fifty Thousand Pesos (PhP 1,450,000.00);

WHEREAS, in compliance with the pertinent provisions of Republic Act ("RA") No. 9184, otherwise known as the "Government Procurement Reform Act", the BAC Secretariat advertised the Invitation to Bid for the Supply and Delivery of One (1) Unit Brand New Van (PB-24-22) dated 28 June 2022 in the Philippine Government Electronic Procurement System (PhilGEPS), APUI Website (www.apo.gov.ph), and in conspicuous place at the premises of the APUI Production Unit, Inc.;

WHEREAS, likewise in furtherance with the pertinent provisions of RA No. 9184 that will ensure the transparency of the process, observers from the Commission on Audit (COA) Resident Auditor, as well as observers from the private sector were invited to observe and witness the conduct of the Pre-Bid Conference, Submission and Opening of Bids, Bid Evaluation and Post Qualification as scheduled;

WHEREAS, on 6 July 2022, BAC convened for the scheduled Pre-Bid Conference, no prospective bidder attended the said proceeding;

WHEREAS, on 18 July 2022, the scheduled deadline for the Submission and Opening of Bids, no bidder submitted its bid;

WHEREAS, pursuant to Section 35.1 of the Revised IRR of RA 9184, the BAC shall declare the bidding a failure when:

NOW, THEREFORE, We, the Members of the BAC, by the virtue of powers vested on us by law, after duly considering the recommendation of the Technical Working Group ("TWG"), hereby **RESOLVED** to recommend to the HOPE:

1. To declare a Failure of Bidding for the Supply and Delivery of One (1) Unit Brand New Van (PB-24-22) (PhilGEPS Reference No. 8790982) and;
2. To conduct mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents for the same project pursuant to Section 35.5 of the Revised IRR of RA 9184.
