VARIOUS WASTE AND UNSERVICEABLE MATERIALS

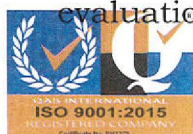
WHEREAS, On January 11, 2023, Mr. Jaime H. Aldaba Jr., EVP and General Manager, approved to dispose approximately 139,333 kilograms of scrap paper trimmings, used core, aluminum plates and used tires through public bidding on an “As-is-Where-Is” basis as indicated below.

WHEREAS, the Invitation to Bid was posted on APO website and conspicuous place reserved for this purpose in the premises of the Procuring Entity for one calendar days on January 29, 2023.

WHEREAS, Disposal Committee convened the scheduled of Pre-Bid Conference on 30th of January 2023. Subsequently, there were two (2) prospective bidders namely, (i) C one C two paper trading, (ii) F.B Azarcon attended the said proceedings.

WHEREAS, on the scheduled deadline for the Submission and Opening of Bids on 31 of January 2023 at 10:00 AM two (2) bidders are present namely, (i) C one C two paper trading, (ii) F.B Azarcon. During the preliminary examination of documents, the committee checked all the submitted documents against the checklist to ascertain if they are all present. All of them passed the eligibility documents, on the later part of the submission and opening of the documents for the 2nd envelope the financial documents C one C two paper trading got the highest bid proposal and subject for detailed evaluation and post qualification.

WHEREAS, during post qualification on 31 of January 2023, the Disposal Committee completed the thorough examination and validation of the minimum eligibility requirements along with the financial documents of C one C two paper trading, they complied, and all documents were authentic and valid after the comparison with the original.

WHEREAS the Disposal Committee declare that the bidding was successful and C one C two paper trading passed and complied with all the requirements set forth by the APO Disposal Committee.


