**RECOMMENDING THE AWARD OF CONTRACT FOR THE
 PROCUREMENT OF THREE THOUSAND (3,000) KILOGRAMS OF BOOK
 PAPER 70 GSM 14"RW THROUGH NEGOTIATED PROCUREMENT (SMALL
 VALUE PROCUREMENT) UNDER SECTION 53.9 OF THE REVISED
 IMPLEMENTING RULES AND REGULATIONS (IRR) OF REPUBLIC ACT (RA)
 NO. 9184**

WHEREAS, on 7 January 2013, Mr. Jaime H. Aldaba, as the Head of the Procuring Entity (HOPE), approved the 2013 Annual Procurement Plan (APP) of Asian Productivity Organization (APO) Production Unit, Inc. upon favorable recommendation of the Bids and Awards Committee (BAC) of the APO Production Unit, Inc.;

WHEREAS, included in the 2013 APP of APO Production Unit, Inc. is the Procurement of three thousand (3,000) kilograms of Book Paper 70 GSM 14"RW for the production of Land Transportation Office (LTO) forms which shall be undertaken through Negotiated Procurement (Small Value Procurement) under Section 53.9 of the IRR of RA No. 9184. The Approved Budget for the Contract (ABC) for the said project amounts to One Hundred Sixty-two Thousand One Hundred Pesos (**PhP 162,100.00**);

WHEREAS, in compliance with Section 21.2 of the IRR of RA 9184, BAC Secretariat posted the request for quotation in the Philippine Government Electronic Procurement System (PhilGEPS), APO Website and conspicuous place reserved for this purpose in the premises of the Procuring Entity concerned for seven (7) calendar days on 29 November 2013;

WHEREAS, on 29 November 2013, the BAC Secretariat sent Requests for Quotation (RFQ) for the Procurement of three thousand (3,000) kilograms of Book Paper 70 GSM 14"RW to the following suppliers, viz;

1. Papermart Corporation
2. TR Paper Products, Inc,
3. Metro Paper Converter Philippines Corporation

WHEREAS, on 9 December 2013, the date of deadline, quotations from three (3) suppliers were obtained by the BAC Secretariat, attested by the accomplished RFQs certified as correct by the BAC Canvasser (Please see Annexes A, B and C);

A. Papermart Corporation	PhP 171,000.00
B. TR Paper Products, Inc,	PhP 155,100.00
C. Metro Paper Converter Philippines Corporation	PhP 160,500.00

WHEREAS, the quotation submitted by Papermart Corporation was automatically disqualified for tendering a quotation higher than the ABC. Further, the quotation submitted by Metro Paper Converter Philippines Corporation was also disqualified due to unavailability of the stocks;

WHEREAS, upon careful examination and evaluation of the eligibility, technical and financial requirements, the proposal submitted by **TR Paper Products, Inc.** was found to have complied with the specifications and other terms and conditions of the project as shown in the Abstract of Quotations herein attached;




This resolution shall take effect immediately.




