Contract Agreement ("Agreement") made and entered into on _____ at _____, between:

APO Production Unit, Inc. ("APO"), a Philippine government instrumentality with corporate power/government corporate entity by virtue of Republic Act (RA) No. 10149 that is attached to the Presidential Communication Office ("PCO"), with principal place of business at 2nd floor, PIA Building, Visayas Avenue, Brgy. Vasra, Diliman, Quezon City, duly represented by its *Executive Vice President and General Manager, Mr. Jaime H. Aldaba, Jr.*;

-and-

Forms International Enterprises Corp., ("Lessor"), a corporation organized and existing under laws and regulations of the Republic of the Philippines, with office address at 26 Carmel Avenue, Project 6, Quezon City, duly represented by its Authorized Representative, **Ms. Bevelyn L. Reyes**;

(each, a "Party" and collectively, the "Parties")



WHEREAS, APO invited Bids for the *Rebidding of Lease of various Paper Printing Machines and Equipment with Operational Support System (PB-02-23-A)* has accepted a Bid by the Lessor for the Procurement of Goods in the sum of *Nine Million Two Hundred Forty-Seven Thousand Five Hundred Pesos (PhP 9,247,500.00)* (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:

- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;


Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of *Nine Million Two Hundred Forty-Seven Thousand Five Hundred Pesos (PhP 9,247,500.00)* or such other sums as may be ascertained, *Forms International Enterprises Corp.* agrees to the *Rebidding of Lease of various Paper Printing Machines and Equipment with Operational Support System (PB-02-23-A)* in accordance with his/her/its Bid.
 4. The *APO Production Unit, Inc.* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
