


CONTRACT AGREEMENT

This AGREEMENT is made and entered into as of this 29th day of April 2024 in the City of \_\_\_\_\_ by and between APO Production Unit, Inc. (hereinafter referred to as the "Entity") and Intertech Forms Manufacturing Corporation (hereinafter referred to as the "Supplier");

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly the *Lease of various Printing Machines and Finishing Equipment with Operational and Technical Support (PB-07-24)* and has accepted a Bid by the Supplier for the supply of the said goods and services in the sum of *Seven Million Nine Hundred Twenty-Two Thousand Five Hundred Pesos (PhP7,922,500.00)* (hereinafter called "the Contract Price").

NOW THEREFORE, for and consideration of the foregoing premises, the Entity and the Supplier hereby agree as follows:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents, as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184, shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. *General and Special Conditions of Contract; and*
  - iv. Supplemental or Bid Bulletins, if any;
- ii. Winning Bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., *Bidder's response to request for clarifications on the bid*), including corrections to the bid, if any, resulting from the Entity's bid evaluation;
- iii. Performance Security;
- iv. Notice of Award of Contract and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Entity concerned in the PBDs. **The Winning Bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of this Agreement.**



3. In consideration of the sum of *Seven Million Nine Hundred Twenty-Two Thousand Five Hundred Pesos (PhP7,922,500.00)* or such other sums as may be ascertained, *Intertech Forms Manufacturing Corporation* agrees to *Lease various Printing Machines and Finishing Equipment with Operational and Technical Support to APO Production Unit, Inc.* in accordance with its bid.
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the bidding.
