

## Contract Agreement

Contract Agreement (“Agreement”) made and entered into on \_\_\_\_\_ at \_\_\_\_\_, between:

**APO Production Unit, Inc. (“APO”)**, a Philippine government instrumentality with corporate power/government corporate entity by virtue of Republic Act (RA) No. 10149 that is attached to the Office of the Press Secretary (“OPS”), with principal place of business at 2<sup>nd</sup> floor, PIA Building, Visayas Avenue, Brgy. Vasra, Diliman, Quezon City, duly represented by its *Executive Vice President and General Manager, Mr. Jaime H. Aldaba, Jr.*;

-and-

**168 Security Inc., (“Service Provider”)**, a corporation organized and existing under laws and regulations of the Republic of the Philippines, with office address at Rm. 2B, 2nd Floor Hizon Building, #29 Quezon Avenue, Quezon City, duly represented by its Authorized Representative, *Ms. Catherine T. Marquez* ;

(each, a “Party” and collectively, the “Parties”)

WHEREAS, APO invited Bids for the *Procurement of Security Services (Multi-Year Contract) (PB-35-22)* has accepted a Bid by the Service Provider for the Procurement of Goods in the sum of *Ten Million Five Hundred Seventy-One Thousand One Hundred Forty-Nine Pesos and 20/100 (PhP10,571,149.20) for the 1st year of Contract* (hereinafter called “the Contract Price”)

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:


- i. Philippine Bidding Documents (PBDs);
  - i. Schedule of Requirements;
  - ii. Technical Specifications;
  - iii. General and Special Conditions of Contract; and
  - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;

- iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of *Ten Million Five Hundred Seventy-One Thousand One Hundred Forty-Nine Pesos and 20/100 (PhP10,571,149.20) for the 1st year of Contract* or such other sums as may be ascertained, *168 Security Inc.* agrees to the *Procurement of Security Services (Multi-Year Contract) (PB-35-22)* in accordance with his/her/its Bid.
  4. The *APO Production Unit, Inc.* agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


